Financial information obtained will be used to collect payment for products and services purchased and for other necessary purposes. Personal information will be used to verify the identity of the user when logging into the system or when necessary.

Statistical and profile information is also collected on our site. This information may be used as needed. It is used for tracking visitor movements and/or providing personalized content.

SECURITY

Our company implements security measures to prevent data loss, unauthorized use, and unauthorized alteration of information. These security measures include:

- Credit card transactions are conducted using SSL encryption technology, ensuring that your credit card information is securely transmitted to our bank via an active SSL Security Certificate.
- Your credit card number is never stored. Only the card number used during the transaction is not tracked or recorded by <u>www.domainnameapi.com</u>. This transaction remains confidential and encrypted between you and the bank, even though the process occurs through our website.
