

# **UK Domain Registration Agreement**

This supplementary agreement applies only to the registration and management of domain names ending in .UK, .co.uk, .me.uk, and .org.uk. ".UK" is the two-letter ISO country code for the United Kingdom.

#### **Preface**

Domain Name API (<u>www.domainnameapi.com</u>) acts as a reseller and technical partner for Nominet UK (the official .UK registry operator), which is accredited to handle .UK top-level domain names.

Domain Name API and its resellers ("RSP") agree to register, renew, and manage .UK (.co.uk, .me.uk, and .org.uk) domain names on behalf of RSP customers through Domain Name API's infrastructure.

The following provisions apply.

### 1. Registration Requirements

- **1.1.** All domain registrars, sub-resellers, and end-users for .UK (.co.uk, .me.uk, and .org.uk) domain names are required to comply with the terms and conditions set by Nominet

  UK.
- **1.2.** Any customer registering a .UK (.co.uk, .me.uk, and .org.uk) domain name is deemed to have read, understood, and accepted the following regulations. Domain Name API requires its resellers and customers to comply with these regulations. **1.3.** The Nominet policies and terms/conditions for .UK (.co.uk, .me.uk, and .org.uk) domain names can be accessed via the following links:

- **1.5.** In addition to the Nominet regulations mentioned above, Domain Name API's general terms and conditions and domain registration policies also apply. Specifically:
- Abuse / Misuse Reporting
- General Domain Name Agreements and Legal Regulations
   These are binding.

#### 2. Resolution of Domain Name Disputes

**2.1.** Any rights, interests, or usage disputes concerning .UK domain names will be resolved under Nominet's Dispute Resolution Service (DRS) Policy and Procedure.

    - **2.3.** The customer agrees that if a dispute arises regarding a .UK domain, Nominet's DRS mechanism may be used, and Nominet's decisions will have direct effect on the .UK domain registration.

#### 3. Duration

- **3.1.** .UK (.co.uk, .me.uk, and .org.uk) domain registrations and renewals can only be made in fixed periods of 1-10 years.
- **3.2.** The customer is responsible for tracking the domain's expiration date and acknowledges that failure to request timely renewal or make payment may result in the domain being suspended or deleted.

## 4. Fees and Billing

**4.1.** The registration, renewal, and associated service fees for .UK (.co.uk, .me.uk, and .org.uk) domains can be viewed through Domain Name API's web interface at the following address:

- **4.2.** All fees are collected in USD. For transactions originating from Turkey, the local currency equivalent of the cart total will be automatically converted to USD based on the daily exchange rate published by the Central Bank of the Republic of Turkey.
- **4.3.** The customer acknowledges that any discrepancies resulting from currency fluctuations or third-party banking/payment provider commissions are their responsibility.
- **4.4.** Domain Name API reserves the right to modify pricing and promotional terms by publishing updated rates on the website. It is the customer's and reseller's responsibility to follow the latest rates.

This supplementary agreement is an integral part of Domain Name API's general domain registration agreement and applies alongside the general terms for .UK domain names.
